CHED SAFE LOAN PROGRAM

GENERAL POLICIES AND GUIDELINES

Qualifications:

To qualify, the student:

- 1. Must be a Filipino citizen and a bona fide undergraduate student of UPLB
- 2. Must be a regular 3rd, 4th, 5th-year or graduating student upon application
- 3. Must be enrolled in the following CHED priority courses:
 - a. CAFS (BSA, BSFT)
 - b. CAS (BSAC, BSAM, BSAP, BSBio, BSChem, BSCS, BSMath, BSMST, BSStat)
 - c. CEAT (BSCE, BSEE, BSABE, BSIE, BSChE) d. CEM (BSABM, BSAEco)

 - e. CFNR (BSF)
 - CHE (BSN) f.
 - g. CVM (DVM)
- 4. Must have earned an overall General Weighted Average (GWA) of 3.0 or better
- 5. Priority will be given to those students under Socialized Tuition System's Partial Discount 80% (PD80%), Full Discount (FD), and Full Discount with Stipend (FDS).

Terms and Conditions:

- 1. The loan shall be secured by a duly notarized promissory note for repayment on or before, or within 2-5 years, after graduation. Repayment can be extended for one (1) more year provided a letter of request for extension of payment has been made and approved by the committee.
- 2. The promissory note shall be co-signed by a guarantor who may be a parent or relative of the principal borrower.
- 3. The borrower must notify the school within 30 days from occurrence of any change of permanent address, status or married name.
- 4. Upon payment, the applicant may apply for another loan.

Requirements:

- 1. Duly notarized application form
- 2. Certified True Copy of Grades (TCG)
- 3. U.P. Form 5 for the current semester
- 4. Proof of billing such as electric bill, water, bill, cable or internet bill and/or Certificate of Residency (must specify whether condition of residency is "owned", "rented", "neither owned nor rented" or "living with relatives") from the Barangay Captain of place of residence.
